Engineer's Report

Rhett Deselle of Pan American Engineers (PAE) reported: (1) on status of Waste Water Treatment Plant; (2) on status of Nixon Addition drainage project.

Holmes added – I spoke with Mr. Deselle pursuant to instructions from the Mayor - I have consulted with four lot owners of property immediately to the west of Veteran's Park / 12th St., their desire to build a fence along their property line. We have two legal issues to deal with; (1.) 15' servitude that the town has along the north side of the main drainage canal that runs through the edge of that property (east / west). We want to make sure we have access to maintain that ditch and (2.) there is a small lateral ditch that burdens two of the four lots that are to the south – Jaquella Manuel and Mr. Benoit - that ditch is wholely on their property. Plans must be submitted to the town so that we can submit to engineers for approval, a set of gates (locked - double 6' gates) that will be built across the back of the property line for the town to gain access (keys to locked gate) to the property in the need the town needs to get equipment inside the gate. Ask if the town will consent to approximately 20-24" of the fence being on town's property line along the backside / south side, due to the way the property line runs. Van Norman asks if it was at the expense of the property owners. Holmes - no expense to the town.

Council Report

Van Norman inquired about the progress of condemnations (Clearance Grant). Van Norman had a complaint of fiber optic companies not notifying homeowners that they are doing work in front of property / leaving exposed facilities / fiber optic lines on right of way. Holmes — Courtesy to advise but if working exclusively in right of way they have the right to work by a franchise or some other statute, legally they are not required to give notice to the adjacent landowner.
